

**SCOTT R. JONES***Sheriff***2020 Year-End RCCC PREA Report**

In accordance with the Prison Rape Elimination Act (PREA) §115.89 (b), the Sacramento County Sheriff's Office must make all aggregated sexual abuse data from facilities under its direct control readily available to the public annually through its website.

Additionally, Standards 115.87 and 115.88 are detailed below and form the basis for this report:

Standard 115.87 – Data Collection

- a) The Sheriff's Office shall collect accurate, uniform data for every allegation of sexual abuse at facilities under its direct control using a standardized instrument and set of definitions.
- b) The agency shall aggregate the incident-based sexual abuse data at least annually.
- c) The incident-based data collected shall include, at a minimum, the data necessary to answer all questions from the most recent version of the Survey of Sexual Violence conducted by the Department of Justice.
- d) The agency shall maintain, review, and collect data as needed from all available incident-based documents, including reports, investigation files, and sexual abuse incident reviews.
- e) The agency also shall obtain incident-based and aggregated data from every private facility with which it contracts for the confinement of its inmates.
- f) Upon request, the agency shall provide all such data from the previous calendar year to the Department of Justice no later than June 30.

Standard 115.88 – Corrective Action

- a) The agency shall review data collected and aggregated pursuant to § 115.87 in order to assess and improve the effectiveness of its sexual abuse prevention, detection, and response policies, practices, and training, including by:
 - 1) Identifying problem areas;
 - 2) Taking corrective action on an ongoing basis; and
 - 3) Preparing an annual report of its findings and corrective actions for each facility, as well as the agency as a whole.
- b) Such report shall include a comparison of the current year's data and corrective actions with those from prior years and shall provide an assessment of the agency's progress in addressing sexual abuse.

- c) The agency's report shall be approved by the agency head and made readily available to the public through its website or, if it does not have one, through other means.
- d) The agency may redact specific material from the reports when publication would present a clear and specific threat to the safety and security of a facility, but must indicate the nature of the material redacted.

The Rio Cosumnes Correctional Center continues to modify and improve the way it handles PREA education, complaints and investigations. During 2019, RCCC underwent a full PREA Compliance audit by a certified Auditor. As a result, many changes were made to policies and procedures to further improve the way sexual assaults are detected and investigated. Additionally, RCCC enacted measures to further improve inmate education and privacy.

In 2020, there were a total of 12 reports filed by inmates at RCCC complaining of sexual abuse that fall within the scope of PREA, as detailed below:

Per PREA §115.5 definitions of dispositions are:

- *Substantiated allegation*: means an allegation that was investigated and determined to have occurred.
- *Unsubstantiated allegation*: means an allegation that was investigated and the investigation produced insufficient evidence to make a final determination as to whether or not the event occurred.
- *Unfounded allegation*: means an allegation that was investigated and determined not to have occurred.

In comparison to last year's data, there was an increase in reports meeting the criteria set forth by PREA. In 2019, there were ten reports of sexual abuse at RCCC meeting the criteria set forth by PREA compared to twelve in 2020. Of the twelve cases reported, two were substantiated, however they did not rise to the level of criminal prosecution. Six were unfounded, two were unsubstantiated and two were referred to outside agencies for further criminal investigation. Although there was an overall increase in sexual abuse allegations from 2019, the total number of substantiated cases decreased while the number of unfounded allegations increased. This decrease may be due to increased safety precautions and monitoring technologies deployed for the safety and security of the inmates in compliance with the PREA federal standard.

After reviewing all reports, it is concluded that all cases were investigated properly and in accordance with the Sacramento County Sheriff Office's policy and the PREA standard.
