### The Position

- Working with the Medical Director and DON's at both facilities, to update and maintain Standardized Nursing Procedures (SNP's)
- Train employees on SNP's
- Develop and maintain a training database
- Develop a comprehensive training and orientation program for all new County Staff and Registry Employees
- Identify training needs and develop new training opportunities for all staff
- Will provide relief for supervisor as needed in the facility

### Minimum Qualifications

- Must have a current RN license issued by the State of California
- A current CPR card
- Must pass a non-sworn law enforcement background
